1. Introduction

This Cookie Policy explains how FUTURA ENERGY DMCC ("Company," "we," "us," or "our") uses cookies and similar tracking technologies when you visit our website at www.futuranrg.com (the "Website"). This policy provides you with clear and comprehensive information about the cookies we use and the purposes for using them.

By continuing to use our Website, you consent to the use of cookies in accordance with this Cookie Policy. You can manage your cookie preferences at any time as described in Section 6 below.

2. What Are Cookies?

Cookies are small text files that are placed on your device (computer, tablet, or mobile phone) when you visit a website. Cookies are widely used to make websites work more efficiently, provide a better user experience, and supply information to website owners.

2.1 Types of Cookies

- **Session Cookies:** Temporary cookies that are erased when you close your browser. They are used to maintain your session while you navigate the website.
- **Persistent Cookies:** Cookies that remain on your device for a set period or until you delete them. They are used to remember your preferences and settings for future visits.
- **First-Party Cookies:** Cookies set by the website you are visiting.
- **Third-Party Cookies:** Cookies set by a domain other than the one you are visiting.

2.2 Similar Technologies

In addition to cookies, we may use similar tracking technologies including:

- **Local Storage:** Data stored in your browser that persists even after you close your browser window.
- **Session Storage:** Data stored in your browser that is cleared when you close your browser window or tab.
- **Web Beacons:** Small graphic images (also known as "pixel tags" or "clear GIFs") used to track user behavior.

3. Cookie Categories

We categorize the cookies and similar technologies used on our Website as follows:

3.1 Strictly Necessary Cookies

These cookies are essential for the Website to function properly. They enable basic functions like page navigation, secure areas access, and remembering your preferences. The Website cannot function properly without these cookies, and they cannot be disabled.

3.2 Analytics Cookies

These cookies help us understand how visitors interact with our Website by collecting and reporting information anonymously. This allows us to improve our Website's performance and user experience.

3.3 Functional Cookies

These cookies enable enhanced functionality and personalization, such as remembering your language preference or region. They may be set by us or by third-party providers whose services we have added to our pages.

5. Third-Party Services

Our Website uses the following third-party services that may set cookies or collect data:

5.1 Vercel Analytics

We use Vercel Analytics, a privacy-focused web analytics service, to collect anonymous information about how visitors use our Website. Vercel Analytics does not use cookies to track individual users and is designed to be GDPR-compliant.

- **Data Collected:** Page views, visitor counts, geographic regions (country-level), device types, browsers
- **Data Not Collected:** Personal information, IP addresses, cross-site tracking

5.2 Content Delivery Networks

We use content delivery networks (CDNs) to efficiently deliver website resources such as JavaScript libraries and fonts. These services may collect anonymous usage

data but do not set tracking cookies.

- **jsDelivr CDN:** Used to load the TopoJSON library for map rendering

- Using browser extensions that block analytics scripts

- Using privacy-focused browsers

Please be aware that if you choose to disable cookies:

- You may see repeated loading animations or quality indicators

We use cookies based on the following legal grounds:

- **Strictly Necessary Cookies:** Used based on our legitimate interest in providing a functional website. These cookies do not require consent.
- **Analytics Cookies:** Used based on your consent. You can withdraw your consent at any time by adjusting your browser settings.

8. Data Protection

Information collected through cookies is processed in accordance with our Privacy Policy. We do not use cookies to collect personally identifiable information unless you have consented to provide such information.

9. International Data Transfers

Some of our third-party service providers may transfer and process data outside the United Arab Emirates. Where such transfers occur, we ensure appropriate safeguards are in place to protect your data in accordance with applicable data protection laws.

We may update this Cookie Policy from time to time to reflect changes in our practices or for other operational, legal, or regulatory reasons. We will notify you of any material changes by posting the updated policy on our Website with a new effective date.

- The right to access information about the cookies we use
